Advance public notice of the Public Group meeting was posted on the County-City Building bulletin board and the Lancaster County, Nebraska, web site and emailed to the media on June 5, 2019.

Group Members present: Dan Nolte, Lancaster County Clerk; Rachel Garver, Lancaster County Treasurer; Pat Condon, Lancaster County Attorney

Others present: Kristen Anderson, Chief Deputy Treasurer; Cori Beattie, Deputy County Clerk; David Derbin, Deputy County Attorney; and Leslie Brestel, County Clerk's office

The meeting was called to order at 10:02 a.m., and the location of the Nebraska Open Meetings Act was announced.

1) Approval of June 7, 2019 Meeting Minutes

Garver noted on page 4, references of "Weber" during Michael Wilson's interview should be amended to reflect "Wilson."

MOTION: Garver moved and Condon seconded to approve the June 7, 2019 meeting minutes with corrections (Exhibit A). Condon, Garver and Nolte voted yes. Motion carried 3-0.

2) Interview – Jim Ballard

Ballard gave a 15-minute presentation on the following questions: "Why do you want to be a County Commissioner?" and "What do you hope to accomplish?"

Nolte asked how to address County infrastructure needs. Ballard answered by prioritizing the needs and looking for alternative funds.

Regarding the County's responsibility for mental health needs, Ballard stated the County has to continue to form community partnerships.

Regarding the levy, Ballard said County needs will determine the budget.

When asked how strategic planning factors into outcome-based budgeting, Ballard answered goals and objectives should be developed, reviewed and funded accordingly.

Public Comment (Note: Public comment will be limited to three minutes per person).

Nolte noted letters of support from the following were received: Lloyd Hinkley, Mike and Charlotte Ralston, Doug and Kathleen Dolezal, and Bruce Bailey in support of Greg Osborn; Randall Moody in support of Christa Yoakum; and Julie Walstrom in support of Tami Soper (Exhibits B-G).

4) Break

The meeting was recessed at 10:25 a.m. and resumed at 10:45 a.m.

Other Business

Condon distributed an email from Michael Wilson (Exhibit H).

5) Discussion on procedures for final interviews

Group members discussed options on how to conduct final interviews including individualized interviews, a round robin format, and the candidates being allowed to summarize their position at the end of the interview.

Public comment will not be part of the June 14 agenda.

MOTION: Condon moved and Nolte seconded that each group member will submit their name and finalists in writing to be read into the record. Condon, Garver and Nolte voted yes. Motion carried 3-0.

It was the consensus of the group to determine the finalist ranking system on Friday.

MOTION: Garver moved and Nolte seconded for each group member to forward up to five (5) interview questions to Beattie for consolidation, to be distributed to and prioritized by the group members for round robin style interviews.

Condon clarified the round robin format.

ROLL CALL: Condon, Garver and Nolte voted yes. Motion carried 3-0.

MOTION: Nolte moved and Condon seconded to allow each candidate two (2) minutes to summarize their interest in the position. Condon, Garver and Nolte voted yes. Motion carried 3-0.

MOTION: Nolte moved and Condon seconded to allow each candidate up to five (5) minutes to answer each question during the interview. Condon, Garver and Nolte voted yes. Motion carried 3-0.

6) Selection of finalists

Garver, Condon and Nolte each submitted their top two candidates to Brestel (Exhibits I-K).

Brestel announced the selections as follows: Garver submitted Christa Yoakum and Tami Soper; Condon submitted Cristy Joy and Jim Ballard; and Nolte submitted Shane Jensen and Cristy Joy.

MOTION: Condon moved and Nolte seconded to notify Christa Yoakum, Tami Soper, Cristy Joy, Jim Ballard and Shane Jensen of their selection for interviews on Friday, June 14. Condon, Garver and Nolte voted yes. Motion carried 3-0.



Advance public notice of the Public Group meeting was posted on the County-City Building bulletin board and the Lancaster County, Nebraska, web site and emailed to the media on June 5, 2019.

Group Members present: Dan Nolte, Lancaster County Clerk; Rachel Garver, Lancaster County Treasurer; Pat Condon, Lancaster County Attorney

Others present: Cori Beattie, Deputy County Clerk; and Leslie Brestel, County Clerk's office

The meeting was called to order at 10:00 a.m., and the location of the Nebraska Open Meetings Act was announced.

Other Business

Nolte announced Larry Scherer withdrew from consideration on June 6, 2019.

1) Approval of May 31, 2019 Meeting Minutes

MOTION: Garver moved and Condon seconded to approve the May 31, 2019 meeting minutes. Condon, Garver and Nolte voted yes. Motion carried 3-0.

2) Interviews

Each candidate gave a 15-minute presentation on the following questions: "Why do you want to be a County Commissioner?" and "What do you hope to accomplish?"

a) David Boeckner

Nolte asked how to address the County's infrastructure needs. Boeckner answered by prioritizing the infrastructure needs and exploring other funding means.

Regarding Condon's question regarding improvements that can be made to the court system, Boeckner stated addressing the mental health needs of individuals in the judicial system is key.

Condon asked Boeckner how he would address funding for mental health and infrastructure. Boeckner answered by cooperating with other government and outside agencies.

b) James Herrold

Nolte asked what funds will be used to fix the road infrastructure. Herrold answered looking at quality technology and materials, and best practices for contracts.

Regarding county priorities, Herrold stated his priorities would be in line with those of the constituents and not any other affiliations.

Garver inquired as to Herrold's thoughts on the increasing jail population. Herrold suggested looking at sentences and prosecutions of non-violent crimes and the privatization of other county assets.

When asked about failed post-release supervision detainees, Herrold stated he would like to partner with County officials to develop a good solution.

When asked about reducing property tax, Herrold said other sources of revenue such as gambling should be explored with funds to be divided between the state and local governments. He also felt selling unused county property could be another revenue source.

c) Shane Jensen

Nolte asked Jensen to address funding and maintenance of rural roads. Jensen said the County needs to look at the infrastructure needs and identify resources to accommodate them while remaining committed to already allocated resources.

Regarding balancing windfarms and Confined Animal Feeding Operations (CAFO) with acreages, Jensen stated he would work on additional development in both wind and solar energy. He would better define zoning for CAFOs and increase farm-to-table relationships.

Condon asked how the County can help working-class citizens. Jensen answered he would make sure those who need services can get them and would explore funding the services with public and private partnerships

When asked how to address community safety versus mental and behavioral health services, Jensen said the County should invest in alternative community programs.

When asked how mental health, public safety, and infrastructure funding needs would be balanced, Jensen suggested identifying the needs first and funding second.

d) Cristy Joy

Joy distributed her presentation (Exhibit A).

When asked about infrastructure funding, Joy stated creative solutions such as a County wheel tax, grant funding and national funding should be explored. She added the County needs to know which roads are most valuable to the constituents.

Garver asked for Joy's perception on mental health services. Joy suggested using the existing County and City skill sets including community programs to benefit the services provided.

Condon asked what is "smart on crime?" Joy said a system that analyzes types of crimes committed and, using the safety of the public as priority, develops different levels of programs to allow individuals to be successful.

BREAK

Nolte recessed the meeting at 11:25 a.m. and reconvened at 11:30 a.m.

e) Gregory Osborn

Osborn distributed his presentation (Exhibit B).

When asked about infrastructure issues, Osborn stated the County needs to work in collaboration with all stakeholders to shorten the longevity of the issues.

Regarding current community safety and mental health issues, Osborn suggested working collaboratively to give individuals the opportunity to have a positive relationship within the community.

Garver asked how Osborn would deal with the lack of funding to cover all the County's needs. Osborn responded by prioritizing needs.

f) Larry Scherer

The candidate withdrew from consideration.

g) **BREAK**

The meeting was recessed at 11:45 a.m. and resumed at 12:31 p.m.

h) Tami Soper

Soper distributed her presentation (Exhibit C).

When asked how to balance the community and infrastructure needs with the budget realities, Soper stated she would identify the priorities, streamline resources, make responsible investments and foster public and private partnerships to meet the needs of the people.

Condon asked Soper for specifics on merging City and County entities and for funding requirements relating to the court system. Soper said better communication between government agencies could streamline processes. Regarding unfunded County mandates, she suggested including funding requirements on the County's legislative agenda. Soper also stressed the importance of strengthening partnerships to address the mental and behavioral health needs of individual waiting in correctional facilities.

i) Brodey Weber

When asked about funding for infrastructure, Weber said additional funding is needed through wheel tax and sales tax. Additionally, a master plan for facilities and a capital improvement program are needed.

In response to Condon's inquiry, Weber stated the County should work with state officials to help reform the justice system.

Garver asked Weber about the County's responsibility of helping individuals with mental health needs. Weber felt the County needs to serve individuals before the privatization of the County's mental health facilities. He added incremental funding to improved services would be needed.

j) Michael Wilson

Nolte asked where roads and bridges fall as a priority in the budget and how one balances renewable energy and acreages. Wilson answered he would prioritize roads and bridges. Regarding renewable energy, he said he would make sure constituents understand the full impact of renewable energy.

When asked about the Board's responsibility on mental health services, Wilson felt the County should invest in public and private partnerships.

Condon questioned Wilson's statistic from the American Civil Liberties Union-Nebraska regarding the number of individuals in jail who have not been charged with a crime. Wilson clarified he is looking at issues within the criminal justice system to see what can be improved upon.

When asked how to fund mental health partnerships, Wilson responded by prioritization and raising revenue.

k) Christa Yoakum

When asked how to balance infrastructure with public safety, Yoakum answered the community needs to come together to make decisions. Additionally, revenue will need to be raised.

Regarding the County's responsibility with mental health assistance, Yoakum stated more local community services, partnerships and funding are needed.

When asked about funding community safety programs, Yoakum said the County should look to both long-term and immediate results along with proven successes and guide funding solutions accordingly.



I will be completely involved at meetings, committee work and community engagement.



I can tell you with absolute certainty. If I am chosen to fill this vacancy. I will play a dedicated role in dealing with the diverse challenges the board faces today and into the future.



- 3. Put the best interest of the people in Lancaster County District 2 before politics.


ONE: To be responsible steward of the public's dollars

Good afternoon,

My name is Don Mayhew, spelled D-O-N M-A-Y-H-E-W. As you know, I'm a member of the Lincoln Public Schools Board of Education, but I'm not here in that capacity. I'm speaking today as a private citizen in support of Christa Yoakum as a candidate for County Commissioner.

I'd like to start by offering you my gratitude and congratulations for your work to craft an interview process that is fair and transparent. I know from experience how hard it can be to navigate all the challenges, and I appreciate this chance to speak with you.

You have a very important duty in front of you – selecting somebody to serve on an elected body without the benefit of having been chosen by election. As you all know from your own service, nobody really understands the intricacies of the budget, or the challenges of certain issues until they have spent some time working with them. Right now, you have a pretty unique opportunity to perhaps concentrate less on specific issues and to focus more on qualifications and experience. You have the opportunity to choose the person who you feel has the skillset to become the most effective policy maker and problem solver.

Having 18 years of experience working with an elected team, there are characteristics I've come to observe and value in my colleagues who are the most effective in their service. Team members who are willing to do their homework on issues and show up to meetings prepared; having the integrity to keep their word once it's given; having excellent communication skills; having past board service to draw from; having many connections with the community, so as to facilitate communication and garner meaningful feedback from stakeholders; having the ability to talk respectfully and intelligently with people from all political leanings.

I know several of your candidates and many of them could be successful commissioners. But I believe that Christa is an especially strong candidate who would be a particularly effective team member.

On top of her employment and her job as a mother, Christa also serves (and has served) on many boards including the Community Health Endowment, the West Lincoln Community Resource Center Board, and the YWCA Board. In addition, Christa has co-chaired the New Americans Task Force and has served the school district by participating on the LPS Strategic Planning Task Force, our High School Task Force, and by going through our Citizen's Academy. Her service speaks to a wealth of experience, connections with our community, and her incredible work ethic.

I think that Christa's work on the Strategic Planning Task Force is an excellent example of her talent and ability. LPS staff gathered a mountain of data and feedback from community members about their concerns and hopes for the school district. As part of the team, Christa's job was to sort through all that data, summarize it into cogent themes, and then turn that into specific and actionable recommendations for the school board. The result of that work was the LPS Strategic Plan, a document that will guide our most important decisions for the next several years. I think that this experience is one of many that gives Christa the experience and perspective to be especially effective as a Commissioner.

The last point I'll make would be to point out that the City Council is also going through a process to select a new team member. One of the dynamics they are considering is to choose somebody similar to the person they are replacing. As Christa is a like-minded woman, I think that choosing her would be perceived by many people as being incredibly respectful of the electorate that originally chose Jennifer Brinkman. I would also note Christa's recent campaign for the Public Service Commission. Christa's bid fell short, but inside the county she earned the majority of the votes. Of all your candidates, I believe she already has enormous support in the community that she would serve as a Commissioner.

This is Michael Wilson. I interviewed for the County Commissioner seat Friday afternoon. I wanted to follow up with you in regard to the comments I made concerning the justice system in Lancaster County.

First, I wanted to explain that I was intending for my remarks to come off as aggressive or offensive, in any way. I hope they were not received that way.

I believe that your office has done great work in implementing a series of alternative programs that focus on rehabilitation and returning citizens.

The point I was attempting to make is that, amidst all this good, there are pieces of the system that would benefit from amendments. In the course of perfecting our system, a willingness to recognize short-comings of a system will ultimately benefit all of us.

Below I have attached the full report released by the ACLU. I have attached two important quotes from the report as quick reference.

I appreciate the opportunity to be considered for this position and for your time.

"The Vera Institute reports that, nationally, 60% of jail inmates are pretrial, meaning either they have been denied bail or, more frequently, are unable to post bail.10 Out of our sample, we found that over half of inmates in Nebraska are pretrial defendants who are not convicted and presumed innocent."

"Many defendants are incarcerated for nonviolent crimes. An average of 17.5% of the pretrial defendants in the surveyed counties were in jail for nonviolent drug offenses. 11.4% were theft and shoplifting charges, and 7.3% were traffic related charges. In total, over half of the pretrial population were accused of nonviolent offenses."


